- a) Parish Hall Cllr Munn

b. Highways -

Road by Clannacombe Hill in East Buckland is a mess - Agricultural (by Mill Pond) – needs to be cleaned up as it is a hazard to public – bill can be sent to Home Owner. **Clir Gilbert to take up with Highways.** 

Cobbles by the church – Parking area – car has been there for 7 weeks – has been reported to the police but it is on private land. Can put a notice on windscreen – giving 30 days notice that it will be removed. (Car is now gone!)

## c. Footpaths & Heritage Coast

The coastal footpath by the Golf Club house (Leas Foot Beach) is getting worse.

## d. School - Cllr Rhymes

No report and should be deleted from future agendas.

#### e.Trees - Cllr Mitchelmore

All quiet at the moment – Mr G Stidston,s trees have been done.

### g. Parish Plan

**Mast** – still waiting to hear from Arquiva/Harlequin – it could be they are having problems meeting criteria ie Line of sight – between transmitters, power supply to site, low rental for site etc

Mast for Bigbury on Sea – Bigbury Parish Council have met (Cllr Came & Munn attended) and have proposed site for a new mast at Mount Folly Farm – this will give coverage for Bantham and perhaps some of West Buckland.

Broadband – Have been advised that they are on track with surveys – however we need to ensure that installation is still on track by end of 2015 as promised. Cllr Gilbert will contact BT for an update.

# h. Parish Clerk Report

- Thanked Cllr Rhymes for replacement Holly tree by memorial put in to replace the Len Hubbard Xmas tree which had died again. Invoice needed so we can pay for it This was provided and will be paid next month.
- New Parish Hall Key for Clerk has been requested and will cost £20.54 discussed and -Resolved that this should be ordered asap.
- New notice board in West Buckland
   – have key which is very large and only have one! Have spoken to the church and they will sort out their own board which hopefully the Parish Hall and others can use.
- Precept for 2015/2016 now due and forms received. This was discussed at end
  of the meeting after budget/projections were provided to the council. After
  discussion it was decided that a 2% increase was appropriate for the coming year.
  An election will happen in May (Cost budgeted for) and services are being pushed
  down from SHDC to ourselves.
- Resolved Clerk to complete form and apply for 2% increase.

#### 4. Dist and County Councillor Report

## Dist CIIr Bramble report given – which covered

- Unoccupied property in Sea View Terrace tenant has advised that it is their main residence (this is unlikely as they are never there!) So still being investigated.
- Central Government have muted that they may ask for high spending Parish Councils to be audited although in practice this will be difficult to implement.
- Councils financial position transformation project is proceeding well
- Substantial savings being made and on target with expenditure and revenue for 2014/2015. Also both Senior Directors appointed now.

#### **County Cllr Gilbert – report covered**

- Devon schools results are in top 10 for UK.
- Pot Holes are now 500/600 per week was 3000 a week at peak.
- Bridge wall at West Buckland due to be done by end of financial year has been started today!
- Need to save £1m per week going forward.
- Flood on road on road out of Thurlestone towards Churchstow end still a problem and needs sorting out.

# **5.Police Business**

Not present – again – but did send E mail which advised that since beginning of December only one instance of crime which was criminal damage to a property in Bantham – offender was arrested at the scene and is currently on Bail.

Also are in possession of a camera found on Bantham beach before Xmas.

Resolved – can we advise that we want to see them and can they help re car by church.
