- a) Parish Hall

Highways – Parking

There are still three unresolved issues in West Buckland

- Firstly the gulley by Woodlands still not unblocked
- Secondly 4 inch drop in Tarmac by the Phone Box
- Thirdly the wall on top of the bridge still not done.
- These have been reported some going back 12 months

Adam Keay (Highways) – has replied to our Email and they are all in hand but may not be actioned until after April – this is not acceptable as it could result in a blocked road – Rufus will take up with Adam Keay urgently and see if he can sort out ASAP.

Resolved – Clerk to send an E mail to Rufus with details.

b. Footpaths & Heritage Coast/Thurlestone Sands

Pot holes at Glebefield and road to Bantham from West Buckland need to be reported Hope Cove coastal path should be open by Easter.

Thurlestone Sands – will have a quick meeting after council meeting to discuss further action.

d. School - Cllr Rhymes

Nothing to report.

e.Trees - Cllr Mitchelmore

Very quiet at moment. Martin Grose has received permission to take a large tree down.

f. Parish Plan -

Mobile Phone Mast - Cllr Came

Department of culture fund community projects for mobile coverage and Arquiva arrange this – has spoken to them and they sub contract this to a company called Harlequin.

Will need to survey but advised that Bantham is not a problem as can get signal from Bigbury.

Will need a drop in meeting to go through plans – so community on board before it goes forward to planning. Need to sort out date and advertise.

Broadband Meeting – took place at Hotel and it was felt that the community is being ignored as no vote was allowed and it will now be up to BDUK to decide who to use! John Hart has agreed to meet with the South Hams Broadband Team to discuss their concerns.

g. Parish Clerk Report

Report covered

Wrote to South Devon Rural Housing Association regarding the New Houses
At Parkfield opposite the Pub – have replied and confirmed they have not yet finished the rear gardens – Clerk to ring and find out exactly what is to be done and report back.

Pavement by monument has been cleaned and have done a good job.

Sign at Whitley Cross has been reported and will be done asap.

Graham Worrall (Church Warden) has asked if the council will consider a donation towards the Cost of the Church Tower repairs (£150K) – asked if it could be put on the agenda for next month – after discussion it was decided not to do this – as it was felt we could not help.

4. Dist and County Councillor Report

- Report then given by County Cllr Rufus Gilbert which covered-
- From 1st April the responsibility for parking on the street will be Devon County council,s responsibility not SHDC.
- District council have made £130m in savings so far and need to save another £50m
- It is felt that eventually local government will have to be self sufficient in the future and will not receive any funds from central government.
- The cut backs will have an effect on pot holes/highway repairs.
- Schools get very little £100 per child in South Hams compared to £400 per child
- Nationally.

Ian Bramble(District Councillor) – gave report and covered the road sweeping issue on the Mead (Unadopted Road – so not responsible for its clesaning/upkeep) and also the cobbled road – there may be a possibility of funds from the community fund project fund – which has a new homes allocation for maintenance of roads. Will look into it for us.

Boundary commission report will be out soon – so will be able to see how this effects us.

5.Police Business

Not present – but gave a report by Email – which advised they had caught the people responsible for thefts from boats in Bantham as a result of CCTV.
