# Minutes of the Parish Council Meeting held on Monday 6th February 2012 at 7.30pm in Thurlestone Parish Hall Thurlestone

The Chairman opened the meeting at 7.30pm and welcomed everyone. It was explained that we would have an **open forum** at the beginning of meeting for any matters that public wished to raise. This section is not minuted.

#### **Open Forum**

1. Apologies for absence and to consider whether to approve reasons given.

2. The minutes to confirm and sign the minutes of the Parish Council meetings held on Monday 9th January 2012. LGA1972, Sch 12 para 41(1).

Resolved – that the minutes of the Parish Council meeting held on Monday 9th January 2012 were signed as a correct record.

- 3. Matters Arising:
  - a) Parish Hall Report by Cllr Hurrell

Not a lot to report – maintenance meeting recently held and discussed purchase of clock for Diamond Jubilee.

Have ordered new bollards to put outside in road.

## b) Highways

Had meeting with Adam Keay (Highways) on Friday 20<sup>th</sup> January and drove around the area pointing out the various pot holes, blocked drains etc.

#### **West Buckland**

- Grove Corner Pot hole hidden by surface water stream across road should go under
- But the pipe is blocked needs digging out and pot hole repaired.
- Bridge over stream gulley to river is blocked up and pipe on bridge is also blocked will need
- Clearing.
- Pais Arrish wall is falling down and could block road needs attention.
- Road from West Buckland to Bantham also needs some attention.
- Bantham road out to the A379 pull ins need clearing.
- From A379 Road into Thurlestone from Churchstow Various Pot Holes half way to Whitley Cross
- Have been filled in but badly most of the tarmac used has been pushed out to side of road
- so was not effective and will need to be done again!!!
- Burnt House West Buckland there is a large pot hole just outside covered by water and a lot of mud.
- Chapel Cross Langmans Cross drain blocked so water is running past it down the steep hill there
- Causing problems further down.
- Brook Hill bridge over stream by South West Water depot –Drain blocked by a lot of mud/debris so water is not draining into the stream – needs some major clearing.
- Finally in Thurlestone
- Court Park Road to the Mead is a public footpath but is now dangerous in view of the poor condition of the road. It is a private road but a footpath needs to be restored!

Pot holes must be 4" deep before they are repaired and it all comes down to money – some of the above list will only get done if funds available.

There is a big pot hole by entance to tennis courts needs to be reported – **Resolved to Report.** 

Suggested letter to Sir Simon Day to come to our Annual Meeting and we can then raise these issues with him. **Resolved to write to Sir Simon Day.** 

# C. Footpaths & Heritage Coast/Thurlestone Sands

Concerned re state of cobbled road by the Church/memorial – will only get worse over next few months as a result of the very large building lorries going over it onto Yarmer estate. Will Yarmer pay towards the cost of repairing this road?

Cllr Mitchelmore to approach Derek Brown (Yarmer Estates) to discuss.

Cllr Goddard has drafted a response to Ordnance Survey reply to our letter re Thurlestone Sands and was discussed – **Resolved to send reply.** 

#### D. School - Cllr Rhymes

No report.

#### e.Trees - Cllr Mitchelmore

Not a lot to report – there are a couple of issues that need to be resolved. Branches affecting a Thatched roof, need to be cut back opposite Toyes Orchard by raised footpath- Cllr Mitchelmore will talk to owners and see if can be resolved.

Pays Arrish there are some dead trees overhanging the road – again will need to talk to land owner.

#### F.Parish Plan - Cllr Came

**Broadband** – We currently have .8 mb speeds in the Village compared to 7/10 mb which is what we should have. Plans are to get 90% of country up to 24mb over next few years. 10% hard to reach (this includes us). If not careful we will be left behind.

Recently had 3 meetings and managed to get an application in before deadline of 31<sup>st</sup> January for funding. Hope this is successful.

Alternatively we are looking at possibility of a spur off the Schools fibre optic broadband if possible? Best Solution not yet found could be combined with mobile signal.

**Mobile Phone mast** – Have found company – The Phonemast Company will arrange a £350 survey – if ok they arrange for mast – and get 50% of first years rent. However mobile coverage could be combined with the broadband solution and need to investigate.

#### g. Parish Clerk Report

E mail from Parishoner regarding sheep on the road into Thurlestone – this is happening regularly and is stopping traffic. Problem is lack of fencing between fields. Asked if council could approach Farmer about this.

#### Resolved to write letter to Farmer.

**Snow Warden** training arranged and completed – grit has been delivered – result. Did tour of Village with Cllrs Hurrell and Mitchelmore together with Adam Keay (Highways) Regarding road problems (See separate report).

**Planning System Explained** – course Wednesday 29<sup>th</sup> May at The Watermark in Ivybridge It is FREE – but must go or charged £10. Cllr Munn and Clerk will go plus anyone else interested.

**Phone box** by Village Shop is now officially ours and we can get on and paint it etc. Advised by BT that there is no electric supply to the box.

#### 4. District Councillor's Report

Report given by our district councillor – This included:

As end of financial year approaches covered all the budget savings SHDC have achieved by rationalising services with Devon County.

More recently have done reviews of Senior and Middle Management resulting in further savings. Need to decide on Council tax – will be voted on soon.

Could freeze but will probably go for 2.5% to keep in line with inflation.

Answered questions regarding planning issues.

**Resolved** to have meeting with Cllr Goddard and Clerk to discuss how as a council we can liase/ work with Planning going forward. We should also write to Head of Planning if we feel as a council that we are not being listened to.

#### 5.Police Business

No Report – not present.

#### 6. Business by Direction of Chairman

**Diamond Jubilee** – note in Village Voice resulted in 2 people coming forward to volunteer help – have 8 people now. Registered to have beacon.

Our main celebration will be on the Sunday – Ram Roast, Street party etc

Request for donation from council towards cost of clock at Parish Hall.

**Resolved to pay £150+** but will wait until all fund raising has been completed and may then give more.

**Snow Warden** – training completed and has 5 ton of grit by his house! Will spread this around the Parish – Evans estates will have some for Bantham. School may have some. This is for use on Public Highways only.

Need to check our insurance covers this.

Kerb Stones – for use by Village sign – not got enough yet – but need to get a quote regarding laying them.

Resolved to approach Highways about this – to get idea of cost.
