a) Parish Hall - Report by Cllr Hurrell

Brief report given – shelving should be available for loft area to facilitate storage/filing for the council documents. Magnetic catches now fitted. Kitchen being made larger has been discussed and will not be taken forward.

b) Highways -

West Buckland – roads have been looked at by Adam Keay (Highways) – and has been put on list to be done. Concerns raised that road could collapse and is very urgent. Meeting would be welcome with Adam and will request this.

Large pot hole reported between Whitley Cross and Elston Cross by Green Lane – will report to Highways.

The parking space by Grove cottages looked at by Highways and sign would not be appropriate. Suggested we have a word with owner – **will do letter as well.**

Resolved - Clerk to write letter and request meeting with Highways re roads in West Buckland.

c) Footpaths & Heritage Coast

Missing sign on golf course has been replaced.

d) School - Cllr Rhymes

School – official opening tomorrow at 2.00 pm by Bishop of Plymouth – will be open to the public from 3.00 pm onwards.

Problem with gates banging of a night – should be sorted as snagging list has now been completed.

e.Trees - Cllr Michelmore

There are some dead Elms by the Hotel tennis courts that need to be sorted out. Trees by Swallows also need to be cut back from the road.

Whilst Cllr Mitchelmore is our tree guru he is not sure why he is continuing to get planning applications for Wembury and Plympton property from SHDC!!!

Relatives of the late Len Hubbard will be down soon and it was raised if we had decided on a tree by the church as a memorial yet. It was decided that a meeting will be held on Wednesday at 5.30 pm to make a decision on type of tree and location.

f.Parish Plan -Cllr Came

Has now met with Kit Marshall and Alan Taylor Bigg and taken over the actioning of the plan going forward. There are 16 action points in all which include village signage, Broadband speeds etc

Will need 5 or 6 volunteers to help implement plans.

Malcom Le Grice will look at signage and report in September.

Richard Swann will be looking at technology infrastructure – meeting on Thursday with Devon Renaissance, School and Hotel regarding optimising internet speeds.

g. Parish Clerk Report /Thurlestone Sands

Thurlestone Sands – nothing to report yet but should have something by next meeting.

PAYE now set up and hopefully will get paid this month. Expenses will continue to be drawn by cheque.

E mail from highways read out re West Buckland roads situation.

Letter received from Sam Rhymes (Aged10) asking if would consider goal posts for the childrens playing area at Island View. Again will pass around in circulation and we can discuss at next meeting.
