Open Forum

Chairman opened the meeting by allowing members of the public to express their views on any of the planning applications to be considered. They were asked to try and keep their statements to 3 minutes each. This took approximately 15 minutes.

Planning

Application 55/1592/11/F – First Floor extension over existing garage, first floor extension over existing single storey garden room and single storey extension to form new garden room at 11 Edwards Close, Thurlestone TQ7 3BP by Mr & Mrs P Pool.

Objection – Following site meeting on Wednesday last week – Cllr Munn had declared a preferential interest and left the room. Cllrs Voted 4 to 1 against the application.

It was felt that this was an overdevelopment of the site in that this is not a stand alone property but was designed as part of a cluster of other properties to be one cohesive whole where the roof lines, textures and colours of the houses that make up the development were carefully calculated to contribute to a pleasing total effect. Although on the face of it allowing the roof level either side of the main house to rise is not a major alteration to the look of that one property it will we believe affect the homogeneity of the development.

It will also set a precedent and encourage other house owners within the development to alter their properties and this will detract from what at present is a pleasant looking development.

The application also allows for overlooking from windows into neighbouring properties resulting in a loss of privacy and has an overbearing impact on adjoining property.
