1 Respective responsibilities of the auditor and the authority

Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance with Proper Practices and no other matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

The AGAR was not accurately completed before submission for review. Please ensure that amendments are corrected in the prior year comparatives when completing next year's AGAR. The authority has confirmed that the figure in Section 2, Box 3 for 2022/23 should read £3,929.

Other matters not affecting our opinion which we draw to the attention of the authority:

The smaller authority has indicated in the Annual Governance Statement that it has not complied with electors' rights in 2022/23 by answering no to Assertion in Section 1, Box 4. In the prior year external audit report the external auditor noted that the notice of conclusion of audit was not published on the authority's website by the dates specified in the Accounts and Audit Regulations 2015, this was in relation to the 2020/21 audit which should have been published in 2021/22 and does not impact 2022/23.
